Asia Classification Society

The classification of ships includes the development/clarification of construction standards, manner of inspection, design appraisal and supervision on the construction of all ships, offshore and onshore structures in accordance with IMO and national regulations.

A vessel designed and constructed under the rules and regulations of a classification entity, shall receive that entity's specific classification certificate. Ships' sailing permit shall be issued in case of the verification of their technical competency which is called classification.

ACS was established in 2005 supported by 25 years' experience of its founders, namely, IGS(Iran Group Of Surveyors) and IBS. As two independent entities these organizations were, for many years, actively involved in technical and safety inspections as well as classification surveys.
